2. Proposal 2: Adoption of the Proposal for Distribution of 2022 Profits.

#### **Description:**

- A. The Company's net profit after taxes for 2022 was NT\$800,915,427 by deducting the set aside legal reserve of NT\$80,091,543, the available earnings at end of the period is equal to NT\$720,823,884, each common share holder will be entitled to receive a cash dividend of NT\$1.6 per share, the Company plans to distribute dividends of NT\$269,646,264 to shareholders.

- C. The cash dividend distribution will be calculated to the nearest NT dollar, the remainder will be transferred into the "Other Revenue".
- D. Subject to the approval of the regular shareholders' meeting, the ex-dividend date for the cash would be decided by Chairman.

If the number of total shares outstanding, prior to the ex-dividend date for the distribution, has changed due to the repurchasing of shares by the Company, etc., such that the ratios of the stock dividends and cash dividends are affected and must be adjusted, the Chairman is authorized to make such adjustments.
